

Policy Issuing Companies in the United States for Airlines, Manufacturers & Other Major Risks Business

In the United States policyholders will receive a policy issued by certain licensed affiliates or subsidiaries of the Global Aerospace pool member companies. The insurance afforded by such a policy is provided by these issuing companies whose liability is several and not joint and is specifically set out below. Major risks are written partly on an admitted basis and partly on a surplus lines basis.
