

PRIVACY POLICY FOR CALIFORNIA RESIDENTS

This Privacy Policy applies to personal information of California residents to the extent the information is subject to the California Consumer Privacy Act of 2018 (CCPA).

I. Personal Information We Collect, Use, Disclose, or Sell

We collect information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household (“personal information”).

II. **Your Privacy Rights**

Right to Know

You have the right to request that we disclose to you personal information we collect, use, disclose, or sell about you.

You can visit our website www.Global-Aero.com , email us at Privacy@Global-Aero.com or call us toll free at 1-833-367-4386 to make a disclosure request. You may make up to two requests in any 12 month period.

We do not sell your personal information.

Only you, or someone legally authorized to act on your behalf, may make a verifiable consumer request related to your personal information. You may also make a verifiable consumer request on behalf of your minor child.

Making a verifiable consumer request does not require you to create an account with us.

In order to verify your identity, we will require that you provide to us two forms of identification with at least one of them issued by California or the federal government. We will compare the information provided to the personal information that we possess in order to verify your right to have the information deleted.

We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you.

To the extent that you would like to have an authorized agent make the request on your behalf, we will require two forms of identification as described above to verify your identity as well as a notarized letter of authority executed by you giving the agent authority to make the request on your behalf.

Right to Request Deletion

You have the right to request that we delete your personal information. You can visit our website www.Global-Aero.com, email us at Privacy@Global-Aero.com or call us toll free at 1-833-367-4386 to make a deletion request.

In order to verify your identity, we will require that you provide to us two forms of identification with at least one of them issued by California or the federal government. We will compare the information provided to the personal information that we possess in order to verify your right to have the information deleted.

We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you.

You should be aware, however, that California law allows us to retain your personal information under certain conditions, even if you have asked us to delete it, such as when retaining your personal information is necessary for us to complete a transaction with you or provide you with a good or service you have requested. We will notify you of any denial of your deletion request and the reason for such denial.

Right to Non-Discrimination for Exercise of Consumer Privacy Rights

We will not discriminate against you because you have chosen to exercise any of your privacy rights described above.
